## Nonprofit Letter of Inquiry

### **Overview**

*Women Investing in Shepherd (WISH) is offering two community nonprofit grants for 2026. Grants from WISH are made possible by the generosity of its members who are committed to high-impact philanthropy. Grants are voted on by the active membership on an annual basis.*

*WISH inspires, educates, and develops the amazing potential of women's philanthropy. Our high-impact grants to Shepherd University and the tri-state community affect positive changes, bring new funding resources, and make philanthropy accessible.*

*Letters of Inquiry (LOI) are requested as the initial step in the grant process. Submission of LOI does not guarantee formal consideration for funding. Only groups selected by the Grants committee will be invited to submit full proposals.*

*To receive funding from WISH, a project should be at least one of the following:*

- *Response to urgent and critical needs*
- *Bold new venture; and/or*
- *New approach to ongoing challenges*

### **Eligibility**

**Nonprofit:** To be eligible for a grant from the community nonprofit pooled fund, a grantee must be a 501 (c) (3) organization and provide services in the following counties: Jefferson, Berkeley, Morgan, and Hampshire counties in WV; Frederick, Loudoun, and Clarke counties in VA; and Frederick and Washington counties in MD.

### **Additional Requirements and Exclusions:**

- The grant application stipulates that the organization must expend the full amount of the WISH grant in a time span of no greater than three (3) years (but beginning in the initial grant award year). **We will not consider grants for lesser amounts than the grant award being offered.**
- Applications from organizations that are part of a government agency (including public schools) will not be considered for a WISH grant.

- Applications from religious affiliated organizations that require religious activity or beliefs as part of the service or program requesting funding will not be considered for a WISH grant.
- A nonprofit organization that has previously been awarded a WISH grant must wait five years before applying for another WISH grant.
- Please do not submit any additional materials with the Letter of Inquiry. Any additional materials will be discarded.

### ***LOI Due Date***

All nonprofit LOIs must **be received** by **March 1, 2026** to be considered. You may also copy and paste the LOI fields into a separate document. **All fields are required to be completed in order and in totality to be considered as a complete submission.** Please e-mail one copy of the LOI, a copy of your IRS Determination letter, and all attachments to [mpeterso@shepherd.edu](mailto:mpeterso@shepherd.edu). You will receive an e-mail confirming receipt of your LOI submission.

### ***Grant Size***

Each **nonprofit** grant award (2 each) for the 2026 cycle will be \$36,625. Applicants must show a need for use of the entire high impact amount in a time span of no greater than three (3) years.
